	indicated for payment of the enrolment fee and, where applicable,
	those responsible for processing the data. Your data will not be
	disclosed to third parties unless there is a legal obligation to do so.
Data subject rights	You can access your data and exercise your rights of rectification,
	erasure, objection, restriction, and data portability by sending written
	notice to the General Secretary's Office of the University of Barcelona
